BARANGAY ORDINANCE NO. 02, SERIES OF 2023 A BARANGAY ORDINANCE ESTABLISHING THE POLICY FOR THE PREVENTION, REDUCTION AND MANAGEMENT OF MARINE LITTER IN IPIL, ORMOC CITY, DETERMINING VIOLATIONS AND PRESCRIBING PENALTIES THEREOF

WHEREAS, it is the policy of the state, as per Section 16 Article II of the 1987 Constitution, to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Republic Act No. 7160 or Local Government Code of 1991 Section 305 (h, i, k) articulates the alignment of national and local development projects and programs in its approved budget allocation plan;

WHEREAS, the Department of Environment and Natural Resources adopted the National Plan of Action for the Prevention, Reduction, and Management of Marine Litter (NPOA-ML) under Memorandum Circular No. 2021-10, dated 05 August 2021;

WHEREAS, the National Solid Waste Management Commission also adopted the national plan under NSWMC Resolution No. 1441, series of 2021, dated 12 May 2021;

WHEREAS, the national plan of action forwards the vision of "A Philippine free of marine litter through shared responsibility, accountability, and participatory governance", and an overarching goal of "Zero waste to Philippine waters by 2040";

WHEREAS, the national plan outlined six (6) programmatic cluster of actions and four (4) enabling or cross-cutting cluster of actions that include the strengthening of local government units (LGU) capacities and local level of NPOA-ML, itemed as Strategy 10;

WHEREAS, the Healthy Oceans and Clean Cities Initiative, a joint project of Ormoc City and United Nations Human Settlements Programme (UN-HABITAT), supports the formulation of City Plan of Action in Marine Litter of selected partner cities as contribution to the localization process;

WHEREAS, the City of Ormoc signed the declaration of cooperation for the project on 16 March 2021, while the Technical Working Group was created under Executive Order No. 134 Series of 2021, dated 14 January 2021;

WHEREAS, the Ormoc City Plan of Action in Marine Litter is a result of workshop sessions that integrates targets and initiatives of the Ecological Solid Waste Management Plan 2020-2028 and regular services and programs of the city under the Ormoc City Environment and Natural Resources Department;

WHEREAS, the Ormoc City Plan of Action in Marine Litter was planned from 2023 to 2028, with on-going and sustained projects that falls within the ten (10) strategies outline by the national plan;

WHEREAS, the implementation of this pioneering plan will contribute to the process of implementation and replication in the country;

WHEREAS, the Ormoc City Plan of Action in Marine Litter is a thematic plan that directly address the prevention, reduction and management of marine litter that complements the general target of the solid waste management plan;

WHEREAS, the Ormoc City Plan of Action in Marine Litter 2023-2028 is adopted by the Sangguniang Panlungsod as per Resolution No. 2022-067 dated 13 September 2022; and

WHEREAS, Barangay Ipil, as partner of the Ormoc City under the pilot implementation of the HOCCI Project, developed its own pioneering barangay level plan of action and promulgating these sets of policy statements to further contribute to marine litter reduction efforts of the Philippines;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the Sangguniang Barangay of Ipil of Ormoc City, in its regular session duly assembled that;

SECTION 1. TITLE

This ordinance shall be known as the BARANGAY POLICY IN PREVENTION, REDUCTION, AND MANAGEMENT OF MARINE LITTER REDUCTION OF BARANGAY IPIL, ORMOC CITY. For brevity, it will be called Barangay Marine Litter Ordinance of Ipil, Ormoc City.

SECTION 2. POLICY STATEMENTS

- (a) It is recognized by this Council that successful prevention, reduction, and management of marine litter stems from the primacy of protection and conservation action on both built and natural assets that can be impacted by plastic pollution and other wastes leakage to the marine and riverine ecosystem in the community.
- (b) It is recognized by this council that plastic and other waste leakages to marine and riverine ecosystem is driven by three (3) factors that will be covered by this ordinance.
 - a. Natural processes, including the influence of global warming and consequent climate changes, influence the deposition of plastic and other wastes in marine and riverine ecosystem. This includes wave action and wind direction, consequent fluvial and pluvial flooding, coastal erosion, and sea level rise among others.
 - b. Physical or built development including public and private infrastructures when insufficiently designed to capture and retain wastes will result to eventual leakages in marine and riverine ecosystems. This includes small drainage without trash traps, collection points without proper receptacle enclosures, unplanned built structures along rivers and coasts, and unplanned or occupied water easements in reference to land uses.
 - c. Institutional set-up including budget and waste management enforcement structures when not prioritized, fiscal and human resources allocation will be absent and limited to ensure the progressive implementation of marine litter reduction initiatives.
- (c) It is recognized by this Council that the role of civil society organizations (people's organizations, community-based organizations, non-government organizations) and private entities should be facilitated to ensure consolidated efforts in the locality in combating marine litter.
- (d) It is recognized by this Council that though multi-level governance, forwarded by the Republic Act No. 7160 (Local Government Code of 1992) and Republic Act No. 9003 (Ecological Solid Waste Act of 2000), and composite of city level policies (Ordinance No. 51, Series 2021, (12 January 2021) Ormoc City Single-Use Plastic Products Regulation Ordinance of 2021, Ordinance No. 082 Ecological Solid Waste Management Section Ordinance, Ordinance No. 2017-036 Ormoc City Ecological Solid Waste Management Ordinance of 2017) particularly Executive Order No. 29 July 13, 2019 defined its fundamental role in solid waste management in context of local government structure in the Philippines.

SECTION 3. BARANGAY PLAN OF ACTION IN MARINE LITTER

- (a) The barangay action plan in marine litter developed through the technical assistance of the City Environment and Natural Resources Office shall serve as the fundamental reference in the development, investment, and implementation of marine litter projects.
- (b) The barangay action plan in marine litter shall be funded in accordance with the schedule of its implementation in close coordination with the Ormoc City LGU through Environment and Natural Resources Office (ENRO) under the Solid Waste Management Section (as per Ordinance No. 082 Ecological Solid Waste Management Section Ordinance) and other implementing partners such as national government agencies, local and international development partners, and private funders among others.
- (c) The barangay action plan in marine litter shall be periodically monitored of which implementation status has to be reported by the Barangay Ecological Solid Waste Management

- Committee (as per Executive Order No. 29 July 13, 2019) to the City Solid Waste Management Board in an *annual basis through a year-end review process*.
- (d) The barangay action plan in marine litter shall be reviewed and revised in consonance to the progress of implementation, major development impacts, and natural or man-made shocks or disasters that altered the situation of the locality, while ensuring its alignment to barangay and city development thrusts.
- (e) The barangay action plan in marine litter when formulated as integral to the Barangay Development Plan or Barangay Solid Waste Management Plan shall tag projects that are contributory to the six (6) programmatic cluster of actions and four (4) enabling or cross-cutting cluster of actions of the CPOA-ML and NPOA-ML.

SECTION 4. ADDRESSING MARINE LITTER DEPOSITED IN MARINE AND RIVERINE ECOSYSTEM

- (a) The Barangay shall determine sources of plastic and other waste leakages deposited to marine and riverine ecosystem particularly those that are driven by seasonal changes that alter wave action and wind direction to sufficiently schedule resources during these periods.
- (b) The Barangay shall promptly respond to spills or leakages of plastics and other wastes to the marine and riverine ecosystem under its barangay emergency response unit.
- (c) The Barangay shall promptly notify the Ormoc City LGU through Environment and Natural Resources Office (ENRO) under the Solid Waste Management Section of any marine litter incident, including its estimated impacts and recommendation for a public advisory on prohibitions and permissions.
- (d) The Barangay, if appropriate, shall facilitate with local fisherfolks association or any equivalent community-based or people's organization or government ancillary teams (i.e., Bantay Dagat) to render immediate responses and rehabilitation initiatives from the leakage incidents.
- (e) The Barangay shall implement recovery and rehabilitation of natural assets exposed to plastic and other wastes leakages in marine ecosystem including but not limited to mangroves, coral reefs, sea grasses, and beach forests.

SECTION 5. ADDRESSING MARINE LITTER LEAKAGE POTENTIAL FROM BUILT STRUCTURES

- (a) The Barangay shall strictly implement the observance of easements defined by Presidential Decree No. 1067 or the Water Code of the Philippines. To wit Article 51 Chapter IV Utilization of Waters: "The banks of rivers and streams and the shores of the seas and lakes throughout their entire length and within a zone of three (3) meters in urban areas, twenty (20) meters in agricultural areas and forty (40) meters in forest areas, along their margins, are subject to the easement of public use in the interest of recreation, navigation, floatage, fishing and salvage. No person shall be allowed to stay in this zone longer than what is necessary for recreation, navigation, floatage, fishing or salvage or to build structures of any kind."
- (b) The Barangay shall investigate residential, commercial, institutional or industrial structures that are reported to be contributory to plastic and other wastes leakage to the marine and riverine ecosystem, which report shall contain confirmation on the nature of violation, recommendations to remedy the impact, and if applicable penalties to the Ormoc City LGU through Environment and Natural Resources Office (ENRO) under the Solid Waste Management Section or other government agencies defined by environmental laws on pollution regulations to perform further investigation and sanctions.
- (c) The Barangay shall impose sanction to erring owners or operators of such structures to be determined by the Barangay Ecological Solid Waste Management Committee in accordance with gravity of the violation as per existing city and national laws.
- (d) The Barangay shall progressively manage these regulations within its governance level before escalating to higher authorities.
- (e) The Barangay shall publicize all proceedings relative to the investigation once resolved and decided by the Barangay Ecological Solid Waste Management Committee including its expected course of action or status in the higher competent government authority.
- (f) The Barangay shall ensure approval and implementation of sufficient design of public (i.e., drainages, parks, roads) and waste management (i.e., collection points, materials recovery

- facilities, trash traps, trash bins) structures that decrease the leakage potential of plastics and other wastes to marine and riverine ecosystem.
- (g) The Barangay shall monitor operations of junkshops, individuals, or organizations engaged in collection, recovery, storage, or recycling of plastics and other solid wastes reporting its current stored volume ensuring its within capacity their capacity to reduce leakage.

SECTION 6. PARTNERSHIP AND COLLABORATION ON MARINE LITTER REDUCTION

- (a) The Barangay shall equally support the efforts and initiatives of its constituent population to organize and to be recognized as a body that directly and indirectly contribute to marine litter reduction.
- (b) The Barangay shall provide technical and logistical support to targeted informal solid waste management actors that voluntarily seeks legal accreditation to any pertinent government agencies.
- (c) The Barangay shall enter into formal cooperation agreements with various government and non-government actors that share common interests on marine litter reduction that clearly state its respective goals, objectives, functions, and responsibilities.
- (d) The Barangay shall facilitate the coursing of investments from government and non-government actors to its supported and targeted organizations.
- (e) The Barangay shall ensure transparency and sharing of data on collection, recovery, and recycling to serve as basis to the citywide diversion targets.
- (f) The Barangay shall explore opportunities for financing marine litter reduction projects that can be accessed and tapped including the expanded producer's responsibility schemes among others.
- (g) The Barangay shall participate in all planning, implementing, and coordinating bodies that target the marine and riverine ecosystem to contribute the inclusion of marine litter reduction.

SECTION 7. INFORMATION AND EDUCATION ON MARINE LITTER REDUCTION

- (a) The Barangay shall engage the Department of Education and Ormoc City LGU through Environment and Natural Resources Office (ENRO) under the Solid Waste Management Section in conducting learning sessions on marine litter reduction.
- (b) The Barangay shall support efforts of the Department of Education in mainstreaming marine litter education to the basic education curriculum.
- (c) The Barangay shall conduct *quarterly reporting and learning sessions among its constituents*, in particular new residents and business locators.
- (d) The Barangay shall engage private entities both locators and non-locators in the barangays in providing information and education campaigns on marine litter and solid waste management.

SECTION 8. IMPLEMENTING AND ENFORCING ORGANIZATION ON MARINE LITTER ACTION

- (a) The Barangay shall constitute the Marine Litter Reduction Task Force under the Barangay Ecological Solid Waste Management Committee to serve as Secretariat of all BPOA-ML related initiatives.
- (b) The Marine Litter Reduction Task Force shall be composed of the following:
 - (b.1) *Marine Litter Reduction Task Force Team Leader*. The team leader shall lead the task force that will coordinate, document, and implement marine litter reduction.
 - b.1.1 She/he shall be accountable in monitoring and reporting the progress of BPOA-ML implementation.
 - b.1.2 She/he shall serve as the liaison of the Barangay Ecological Solid Waste Management Committee in all marine litter related initiatives.
 - b.1.3 She/he shall serve as member of the investigation team to be installed by Barangay Ecological Solid Waste Management Committee and Barangay Council on reported violations.
 - b.1.4 She/he shall lead the work of members with focal areas on marine and riverine ecosystem, local organizations, and partnerships and collaboration.

(b.2) Marine Litter Reduction Focal on Marine and Riverine Ecosystem.

- b.2.1 She/he shall be the lead on all related concerns on plastics and other wastes deposited to marine and riverine ecosystem.
- b.2.2 She/he shall serve as the liaison, together with the Task Force Lead, on marine spill events and responses.
- b.2.3 She/he shall be responsible in the implementation of the provisions of Sections 4 & 5 of this Ordinance.

(b.3) Marine Litter Reduction Focal on Local Organizations, Partnerships, and Collaboration.

- b.3.1 She/he shall be the lead on all related concerns on facilitating new and existing community-based or people's organizations on working on marine litter and solid waste management.
- b.3.2 She/he shall monitor on the progress of projects implemented by these organizations.
- b.3.3 She/he shall serve as liaison among organizations, government agencies, and non-government actors on project development and delivery.
- b.3.4 She/he shall initiate actions to facilitate organization building that target informal waste pickers.
- b.3.5 She/he shall be the lead on all related concerns that require forging and forwarding partnerships for and on behalf of the barangay on marine litter projects.
- b.3.6 She/he shall work in actively sourcing and taking collaboration and partnership with the government and non-government development partners.
- b.3.7 She/he shall be responsible in the implementation of the provisions of Section 6 of this Ordinance.

(b.4) Marine Litter Reduction Focal on Information, Education, and Communication (IEC).

- b.4.1 She/he shall develops plans and programs to be able to deliver relevant messages to achieve agreed IEC goals and objectives thru an effective, economic, and efficient delivery mechanism and media.
- b.4.2 She/he shall collect, process, and analyze raw data on marine litter to be used as relevant information for IEC development.
- b.4.3 She/he shall organize community meetings, information dissemination sessions, awareness raising events, workshops, etc. to increase community participation on marine litter actions.
- b.4.4 She/he shall be responsible for the coordination of content development of the Barangay to the marine litter website of Ormoc City.
- b.4.5 She/he shall be responsible in the implementation of the provisions of Section 7 of this Ordinance.

(b.5) Sangguniang Kabataan Chairperson or Kagawad.

b.5.1 She/he shall act as the focal person for youth and children involvement on marine litter action of the Barangay.



- (c) The members of the Marine Litter Task Force shall receive an honorarium, which is to be determined by the Barangay Ecological Solid Waste Management Committee and recommended for approval to the Barangay Council based on the
- (d) The honorarium of the Marine Litter Task Force shall be sourced from the penalties collected from the violations decided by the Barangay Ecological Solid Waste Management Committee Investigation Panel and all other financial sources of the Barangay and/or the City.

SECTION 9. IMPLEMENTING AND ENFORCING ORGANIZATION ON MARINE LITTER VIOLATIONS

- (a) The Barangay Ecological Solid Waste Management Committee shall constitute an investigation panel to document and ascertain the veracity of reported violations within three (3) days upon receipt of meritorious written complaint.
- (b) The Barangay Ecological Solid Waste Management Committee shall qualify a meritorious written complaint when: (1) there is a verifiable complainant, (2) there is sufficient documentation of events leading to the perceived violation, and (3) there is proper documentation of the complaint.
- (c) The investigation panel shall be composed of the Punong Barangay, the members of the Sangguniang Barangay, and the Marine Litter Task Force Leader.
- (d) The investigation panel shall document and determine veracity of the violations and recommend sanctions to the Solid Waste Management Board.
- (e) The investigation panel shall inform the perceived violator of the offense being reported and the process of investigation to be conducted within two (2) days upon constitution of the panel.
- (f) The investigation panel shall seek for other resource persons to further evaluate the investigation findings to further develop and inform the recommended decision when necessary.
- (g) The investigation panel shall have unanimous stand on the determination of the violation and recommended sanction or penalty.
- (h) The investigation panel members shall not receive any compensation.
- (i) The investigation panel shall complete its investigation report to the Barangay Ecological Solid Waste Management Committee within five (5) days after the panel is constituted.
- (j) The Barangay Ecological Solid Waste Management Committee shall decide during the investigation report panel meeting based on the merits and recommended actions effectively immediately.
- (k) The Barangay Ecological Solid Waste Management Committee shall notify the violators of the decision within one (1) day after the meeting.

- (I) The Barangay Ecological Solid Waste Management Committee shall declare all cases without action null and void after eight (8) days.
- (m) The Barangay Ecological Solid Waste Management Committee shall extend the investigation from five (5) days up to ten (10) days, when necessary, upon notification of the investigation panel within three (3) days after the commencement of the investigation.
- (n) Erring individuals, groups, or entities shall settle their monetary and non-monetary penalties within two (2) days of receipt of the decision.
- (o) The Barangay Ecological Solid Waste Management Committee shall communicate its investigation report, including the recommended sanctions and penalty, to the Ormoc City LGU through Environment and Natural Resources Office (ENRO) under the Solid Waste Management Section or to any pertinent government agency.
- (p) There are no appeals to be acted by the Barangay Ecological Solid Waste Management Committee. All appeals shall be raised to the Ormoc City LGU through Environment and Natural Resources Office (ENRO) under the Solid Waste Management Section or to any pertinent government agency.
- (q) All complaints shall be addressed within fifteen (15) days upon receipt of the filed complaint in the level of the barangay government unit through the Barangay Ecological Solid Waste Management Committee.

SECTION 10. MARINE LITTER REDUCTION VIOLATIONS AND PENALTY

- (a) These sets of violations are based on the articulation of potential and/or actual leakage of plastics and other waste that are deposited to the marine and riverine ecosystems.
- (b) These sets of violations do not supersede barangay, city, and national laws that penalizes and disincentivizes violations on segregation and management of wastes.
- (c) These sets of violations focused on verifiable potential and actual actions that pollute marine and riverine ecosystems.
- (d) These sets of violations do not delimit determination of other violations under prevailing laws on segregation and management of wastes.
- (e) The following are violations and recommended minimum and maximum penalties, subject to the determination of the investigation panel and approval of the Barangay Ecological Solid Waste Management Committee:

(e.1) Improper disposal of residential, commercial, institutional, and industrial plastics and other wastes to the marine and riverine ecosystems. This are verified cases of intentional and/or deliberate deposition of plastics and other wastes to seas, rivers, coasts, and within buffer zones including its natural resources (mangroves and beach forests).

- (e.2) Potential leakage of plastics and other wastes from permanent or temporary stationary points. This includes trash bins, collection points, and storage facilities which conditions will lead to leakage to the marine and riverine ecosystem.
- (e.3) Potential leakage of plastics and other wastes from mobile or moving points. This includes trash bins, collection vehicles, and storage vehicles which conditions will lead to leakage to the marine and riverine ecosystem.
- (e.4) Potential conditions are defined as unintended actions or inactions that may lead to leakage of plastics and other wastes to the marine and riverine ecosystem. This may include absence or insufficient waste storage designs, access of other actors other than solid waste management staff of the entity or the household in waste receptacles, unmaintained or wearing collection points and materials recovery facilities, among others.

(e.5) Potential leakage to the marine and riverine ecosystems are defined as those plastics or other wastes contained on these receptacles or infrastructures described to be in potential conditions to leak located within 3 meters to 20 meters from the coasts, rivers, or any marine resources.

- (f) All violation reports shall be periodically reported (quarterly) to the Ormoc City LGU through Environment and Natural Resources Office (ENRO) under the Solid Waste Management Section.
- (g) All violators shall settle their monetary and non-monetary sanctions within two (2) days upon receipt of the decision.
- (h) The Barangay Ecological Solid Waste Management Committee shall escalate to the Ormoc City LGU through Environment and Natural Resources Office (ENRO) under the Solid Waste Management Section all violators who did not comply to the sanctions after 2 days upon receipt of the decision.

SECTION 11. APPROPRIATION

Funding for the projects and activities of the Marine Litter Reduction Program shall be sourced out from the following:

- (a) The barangay share or allocation in the fines collected from violations of RA 9003, City Ordinance No. 36, this Ordinance, and other legal basis;
- (b) Different funding sources of the barangay such as the Annual Barangay Development Fund, Barangay Disaster Risk Reduction and Management Fund, Gender and Development Fund;
- (c) The Youth Development Fund of the Sangguniang Kabataan;
- (d) Donations, endowments, grants and contributions from domestic and foreign sources; and
- (e) Fees collected from provision of solid waste services such as collection, recycling, and transport among others.

SECTION 12. SEPARABILITY CLAUSE

(a) For legitimate reasons that any provision of the Ordinance is declared to be unconstitutional or invalid, the other provisions hereof not so affected shall continue in full force and effect.

SECTION 13. REPEALING CLAUSE

This ordinance shall take effect within fifteen (15) days after its approval and the posting of the full text of this ordinance in two (2) conspicuous places of the barangay.
