



## CDC RESOLUTION NO. 3 Series of 2022

A RESOLUTION APPROVING THE FY 2023-2028 ORMOC CITY PLAN OF ACTION FOR MARINE LITTER AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE ADOPTION OF THE SAME.

WHEREAS, it is the policy of the state, as per Section 16 Article II of the 1987 Constitution, to protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Republic Act No. 7160 or Local Government Code of 1991 Section 305 (h, i, k) articulates the alignment of national and local development projects and programs in its approved budget allocation plan;

WHEREAS, the Department of Environment and Natural Resources adopted the National Plan of Action for the Prevention, Reduction and Management of Marine Litter (NPOA-ML) under Memorandum Circular No. 2021-10, dated 05 August 2021;

WHEREAS, the National Solid Waste Management Commission also adopted the national plan under NSWMC Resolution No. 1441, series of 2021, dated 12 May 2021;

WHEREAS, the national plan of action forwards the vision of "A Philippine free of marine litter through shared responsibility, accountability, and participatory governance", and an overarching goal of "Zero waste to Philippine waters by 2040";

WHEREAS, the national plan outlined six (6) programmatic cluster of actions and four (4) enabling or cross-cutting cluster of actions that include the strengthening of local government units (LGU) capacities and local level of NPOA-ML, itemed as Strategy 10;

WHEREAS, the Healthy Oceans and Clean Cities Initiative, a joint project of Ormoc City and United Nations Human Settlements Programme (UN-HABITAT), supports the formulation of City Plan of Action in Marine Litter of selected partner cities as contribution to the localization process;

WHEREAS, the City of Ormoc signed the declaration of cooperation for the project on 16 March 2021, while the Technical Working Group was created under Executive Order No. 134 Series of 2021, dated 14 January 2021;

WHEREAS, the Ormoc City Plan of Action in Marine Litter is a result of workshop sessions that integrates targets and initiatives of the Ecological Solid Waste Management Plan 2020-2028 and regular services and programs of the city under the Ormoc City Environment and Natural Resources Department;

WHEREAS, the Ormoc City Plan of Action in Marine Litter was planned from 2023 to 2028, with on-going and sustained projects that falls within the ten (10) strategies outline by the national plan;

WHEREAS, the implementation of this pioneering plan will contribute to the process of implementation and replication in the country;

WHEREAS, the Ormoc City Plan of Action in Marine Litter is a thematic plan that directly address the prevention, reduction and marine litter that complements the general target of the solid waste management plan;



WHEREFORE, on motion of Mr. Roque Villaneza Jr. of Sustainable Organic Farmers Association in Ormoc City (SOFAOC), representative from the Civil Society Organization (CSO) and duly seconded by PB Carmelito A. Restauro (District 4), be it;

RESOLVED AS IT IS HEREBY RESOLVED, to pass a Resolution adopting the FY 2023-2028 Ormoc City Plan of Action for Marine Litter and Requesting the Honorable Sangguniang Panlungsod for the adoption of the same;
