



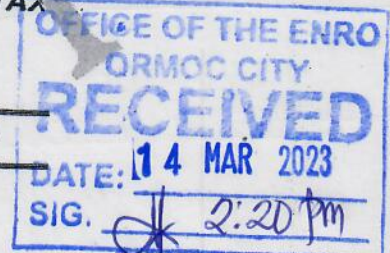

**AN ORDINANCE UPDATING THE GARBAGE COLLECTION  
FEES OF THE CITY OF ORMOC THEREBY REPEALING  
FOR THIS PURPOSE SECTION 3.2.21.2 OF TAX  
ORDINANCE NO. 1, SERIES OF 1977**

**PREFATORY STATEMENT**

Ormoc City has always been known to be a Clean and Green City. A City of Beautiful People, the cost of maintaining its cleanliness, however, does not come free. It entails the intricate process of implementing a waste segregation program at the grassroots, and hauling tons of residual waste per day from source to the Ormoc City Eco-Waste Center. It entails the use of garbage trucks, 2 shifts of garbage collectors per day, heavy equipment operating the landfill, and many other variables which are spent for by the LGU.

The 16<sup>th</sup> Sangguniang Panlungsod received an endorsement dated August 25, 2022, requesting for the amendment of Tax Ordinance No. 1, otherwise known as the "Ormoc City Revenue Code of 1977", relative to the imposition of Garbage Fees;

The request was to update the rate of Garbage Fees as found on the 1977 Tax Revenue Ordinance since costs have increased since then.

Data gathered from the City's Environment and Natural Resources Office (ENRO) revealed that the LGU spends an average of Php54,405,000.00 per year, after it expanded its garbage collection to 97 barangays. However, there are still 13 barangays that have yet to be serviced with regular garbage collection and it is the commitment of the LGU to reach 100% collection of all barangays so as to contain the residual wastes in the Ormoc City Eco-Waste Center in Brgy. Green Valley.

The City Treasurer's Office, on the other hand, shows that the LGU is only collecting a little more than Php300,000.00 annually from the 1977 Garbage Fee of Php45.00 per establishment.

In a research as to how inflation has ballooned prices of basic goods and labor since 1977 up to present, the Ways and Means Committee noted that available data from 1989, 12 years after the effectivity of the Tax Ordinance, the price of rice from 1989 has increased by 344% from Php9.00 per kilo to Php40.00 per kilo; crude oil by 426% from Php938.00 per barrel to Php4,942.66 per barrel; sugar by 572% from Php2,045.28 per Metric Ton to Php13,750.22 per MT; and minimum labor cost from Php79.00 a day to Php350.00 per day or a 343% increase.

Even so, the Gomez administration has expanded its fleet of garbage trucks from three (3) Garbage Trucks in 2013 servicing only the city proper and nearby urban barangays, to 10 garbage trucks servicing 74 barangays in 2019, to 13 operational trucks in 2022 servicing 97 barangays. However, with the ever increasing prices of fuel, spare parts, labor, and cost of maintaining the garbage collection operations, including that of the Ormoc City Eco-Waste Center, the need to upgrade the fees collected to at least subsidize, if not cover, its cost of operation has become imperative.

Section 5 of Article X of the Constitution and Section 129 of the Local Government Code of 1991 provides that: "Each local government unit shall have the power to create its own sources of revenues and levy taxes, fees and charges, subject to such guidelines and limitations as Congress may provide consistent with the basic policy of local autonomy. Such taxes, fees and charges, shall accrue exclusively to the local governments."

Section 47 of Republic Act No. 9003, otherwise known as the Philippine Ecological Solid Waste Management Act of 2000, provides that: "Authority to collect Solid Waste Management Fees - The Local Government Unit shall impose fees in amounts sufficient to pay the costs of preparing, adopting, and implementing a solid waste management plan prepared pursuant to this Act. The fees shall be based on the following minimum factors: a) types of solid waste; b) amount/volume of waste; and, c) distance of the transfer of the transfer station of the waste management facility."

The Committee on the Environment, Natural Resources and Energy Conservation and the Committee on Ways and Means conducted four (4) joint committee meetings on September 29, November 10, December 1, and December 9, 2022, to discuss the request and study the factors that will justify the updating of the garbage collection fees, which have not been updated since the year 1977.

Two proposed ways to upgrade the collection of the garbage fees were studied and discussed. It was also agreed to change the title "Garbage Collection Fee" to "Ormoc City 2022 Waste Management Commitment Fee" to instill a sense of responsibility in everyone to keep Ormoc Clean and Green. One is the traditional way of basing the fee on the kind of business and its potential volume of garbage generated; the other is a simpler method classifying business as to their number of employees. It was also decided that the LGU will no longer collect from large-waste producers such as malls and hotels, and for them to get third-party haulers.

A Public Hearing was conducted on December 1, 2022, together with the concerned stakeholders and resource persons. During the Public Hearing, the audience was informed of the two proposed schemes and the rationale why there is a need to update the fees.

BE IT ORDAINED by the 16<sup>th</sup> Sangguniang Panlungsod in its regular session duly assembled, That:

**SECTION 1. SHORT TITLE** - This ordinance shall be known and cited as the **"ORMOC CITY 2022 WASTE MANAGEMENT COMMITMENT FEE."**

**SECTION 2. 2022 GARBAGE COLLECTION FEES** -There shall be a fee collected from every establishment engaged in business, occupation and/or profession, and any undertaking within the City of Ormoc served by garbage collection, herewith fixed as follows, to wit:




Other businesses not mentioned in this Ordinance will be charged with a fee of One thousand Pesos (PHP 1,000.00).

**SECTION 3. Garbage Service Charge for Multiple Businesses.** - Where there are two or more kinds of businesses subject to the garbage charges conducted in the same place or establishment by the same owner or operator, the charge to be collected shall be based on whichever is higher.

**SECTION 4. Time of Payment.** - The fees prescribed in Section 2 of this ordinance shall be paid to the City Treasurer or to his duly authorized representative within the first Twenty (20) days of January of each year for renewal of business permits or in cases of new applications it will be at the same time with the payment of business permit.

**SECTION 5. Exclusion from Garbage Collection.** - The waste classification described in Article V, Section 17 of Ordinance No. 036, a. Biodegradable or Compostable Waste (including yard waste); b. Non-Biodegradable Waste shall only be collected. Other waste not falling on the said classification shall not be collected.

**SECTION 6. Surcharge for Late Payment.** - For failure to pay the garbage fee on time, the owner or operator of business establishments shall be subject to a surcharge of Twenty-Five percent (25%), and an interest of Two percent (2%) per month, but not to exceed Seventy-Two percent (72%) of the prescribed fee, which shall be collected and paid in the same manner and at the same time as the prescribed fee.

**SECTION 7. TRANSITORY PROVISION** - Businesses/establishments that are considered as large waste generators (including but not limited to industries, malls including their tenants, hospitals, hotels and pension houses or inns with more than twenty-five (25) rooms shall contract a third-party hauler to transport their garbage to the Ormoc Eco-Waste Center and are hereby excluded from paying the Waste Management Commitment Fee. This provision shall take effect on January 1, 2024.

**SECTION 8. SEPARABILITY CLAUSE.** - If for any reason or reason, any part of the provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 9. REPEALING CLAUSE.** - Section 3.2.21.2., Article 21 of Tax Ordinance No. 1 otherwise known as "The Ormoc City Revenue Code of 1977", including all Ordinances and/or Resolutions, or portions thereof, inconsistent with this Ordinance are hereby repealed or modified accordingly.


